NEW MEMBERSHIP AGREEMENT (2019)

***There is a special rate for 2019 first year members:
Dues for Family Membership (3+ family members) are \$600 for 2019 only, plus \$500 refundable stock fee. Family Membership dues after year one to be the full annual dues amount.***

The fee components of new membership are an initiation fee (currently set at \$0), a stock purchase of \$500, and annual dues of \$600 for a Family Membership (2019 only) and \$550 for a Couple Membership. The stock purchase is a one-time refundable payment, while membership dues are an annual fee.

New Membership Payment Options (2019):

Please check your preferred payment option below:

1. Check or credit card payment of \$1,100 for a Family Membership or \$1,050 for a Couple Membership. These amounts include the one-time stock purchase plus the first year's annual dues. Note, for payment by credit card on our website through Pay Pal, a 3% processing fee will be added.
2. Bank draft per the options below. **Pay the one-time \$500 stock fee up front by check or credit card.** Then, simply complete a [Bank Draft Authorization Form](#) and provide a VOID check. This is a one-time requirement as bank draft plans auto-renew each year. Note, each draft includes a processing fee of \$2.50.

By affixing my signature below, I acknowledge and understand that this is a note of indebtedness and that I am personally obligating myself to make the foregoing payments at the schedule selected above. If I fail to make the foregoing payments at the schedule selected above within 30 days of the date said payment is due, I understand that I will be in default on my payment obligation. In the event of such a default, I further understand that Friendly Park, Inc. shall be entitled to retain the payments I have made and, at its election, to accelerate the remaining balance of the payments due and owing at the time of default for the initiation fee, stock, and unpaid dues, and to sue to recover said balance plus interest at prevailing maximum legal rate and reasonable attorney's fees incurred to recover said balance. Failure by Friendly Park, Inc. to exercise its right to accelerate and sue on any remaining balance shall not be deemed to be a waiver of such default or Friendly Park, Inc.'s right to accelerate and sue on any remaining balance at a later time.
